ACAP RECOGNIZES DENNIS HEAPHY OF MASSACHUSETTS WITH 2014 LEADERSHIP IN ADVOCACY AWARD

WASHINGTON – The Association for Community Affiliated Plans (ACAP) today honored Dennis Heaphy, a health care analyst for the Disability Policy Consortium in Massachusetts and co-chair of Disability Advocates Advancing our Healthcare Rights, DAAHR, with the group's *Leadership in Advocacy* Award. Mr. Heaphy was recognized for his efforts to assure key consumer protections for persons with disabilities as aspects of the Affordable Care Act were implemented, including demonstration projects designed to serve persons dually eligible for Medicare and Medicaid. The award was presented today at a gathering of health plan policy leaders in Washington, D.C.

Mr. Heaphy was cited for his leadership role in advocating for improvements to care for individuals living with disabilities through the design of the One Care "duals demonstration" program in Massachusetts. Duals demonstrations are new models aimed at aligning financing between Medicare and Medicaid for states that seek to integrate primary, acute, and behavioral health and long-term supports and services for people enrolled in Medicare and Medicaid. States enter into contracts with both health plans and CMS and have some latitude in the specifics of benefit design.

Among the consumer protections arising from Mr. Heaphy's advocacy are the establishment of a coordinator for independent living long-term supports and services to help medical providers understand the role of non-medical care in overall health and an implementation council comprising a wide range of stakeholders—including persons with disabilities—to monitor the implementation of the OneCare program.

"Dennis exemplifies the kinds of partnerships that Safety Net Health Plans seek as we work to deliver top-quality care—especially for populations such as dual eligibles," said ACAP CEO Margaret A. Murray. "Everyone with a stake in better-coordinated care for dual eligible populations is vested in the program's success, and we rely on input from advocates such as Dennis to make the transitions to the demonstrations as seamless as possible. We're proud to honor him today."

"Dennis has been a tireless advocate both for and within the disability community," said Robert J. Master, M.D., CEO of Commonwealth Care Alliance, which nominated Mr. Heaphy for the award. Lois Simon, President of Commonwealth Care Alliance, added, "Dennis has seized on a unique opportunity to improve care and quality of life for persons with disabilities and has displayed tremendous savvy and persistence during the long and sometimes imperfect process of implementing the One Care program. All of us are in debt to Dennis for his constructive insight and substantial contributions."

"This is a once-in-a-generation opportunity for the disability community to shape our own health care. Disengagement isn't an option," said Mr. Heaphy. "As soon as it was clear that the demonstration was moving forward, it was critical to bring together as many advocates as possible to make sure that these reforms were not just effective, but also equitable—especially for the underserved and those who live with mental illness. Community Care Alliance has been a true partner in our work. I'm thankful for their nomination and glad for the award today."



Before joining the Disability Policy Consortium, Mr. Heaphy consulted with the Massachusetts Department of Public Health, worked on HIV prevention through the Medical Foundation and has served on the faculty of Emmanuel College. He holds a Master of Public Health and a Master of Divinity-Pastoral Care from Boston University, a Master of Education from Harvard University from Boston University and a Bachelors Degree in Business Administration from Boston University.
